On June 15, 2023, the *“China IP Road Show in Texas: Strategies for protecting intellectual property in China”*, is held in Dallas, Texas.

As part of a series of USPTO’s China IP Road Shows across the state, this program is organized by the United States Patent and Trademark Office’s (USPTO) Office of Policy and International Affairs in collaboration with the USPTO Texas Regional Office, the U.S. Commercial Service - Dallas-Fort-Worth, and the Dallas Bar Association.

The program offers a forum where experts from the U.S. government, IP attorneys, and local businesspeople share insights in an array of matters including: *“What small and medium-sized businesses need to know about protecting all types of IP in China”*, *“Enforcing IP rights, in both China and the United States, against infringement originating in China”*, *“U.S. government resources for U.S. companies”* as well as *“IP and China: The Texas experience”*.


